| FEES YOU MUST PAY For an Attended or Unattended burial funeral, the burial fee . ¹ In this local area, the typical cost of the burial fee for local residents is: For a new grave, you will also need to pay for the plot; for an existing grave with a memorial in place, you may need to pay a removal/replacement fee. In addition, the cemetery may charge a number of other fees. | £636 - £2365 |
| For an Attended cremation funeral, the cremation fee . ² In this local area, the typical cost of a cremation for local residents is: | £770 - £895 |

| ADDITIONAL FUNERAL DIRECTOR PRODUCTS AND SERVICES This funeral director may be able to supply a range of optional and additional products, or to arrange (on your behalf) for a third party to supply them. Examples include: | |

| Additional transfers of the deceased person's body (e.g. to their home, to a place of worship etc.) (price per transfer) | £295 |

¹ This fee (which is sometimes called the interment fee) is the charge made for digging and closing a new grave, or for reopening and closing an existing grave.

² In England, Wales and Northern Ireland, you will usually need to pay doctors' fees as well. This is the charge for two doctors to sign the Medical Certificates for Cremation.
